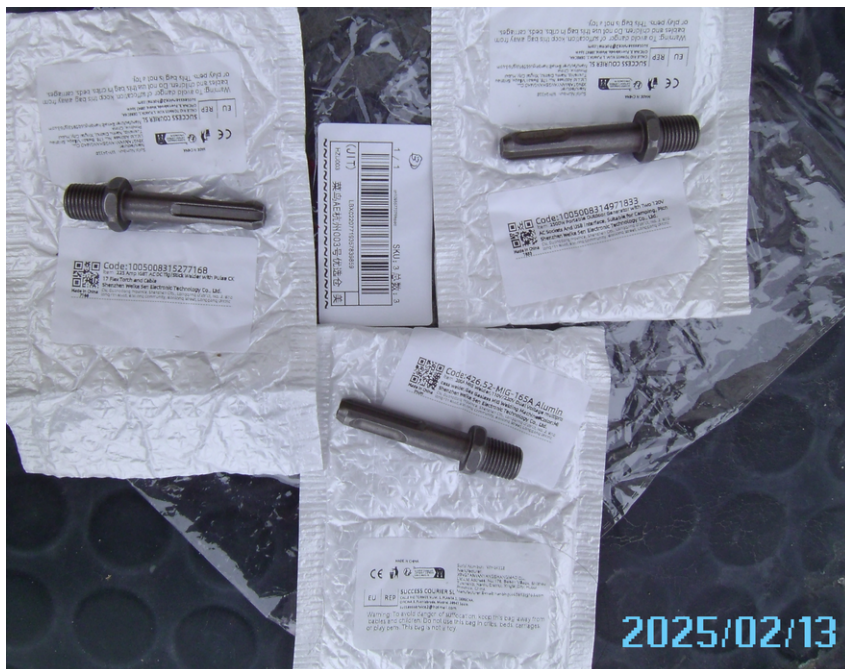

Trinket: [Webster's New Collegiate Dictionary; 1977. 1- trin.ket n. 1: a small article of equipment 2: a small ornament (as a jewel or ring) 3: a thing of little value : TRIFLE 2- trinket vi. : to deal clandestinely : INTRIGUE -- trin.ket.er n.]. One person had no clue what I was talking about!

I find it very interesting that out of the ten (10) orders I made, only three (3) orders were filled with the products that were ordered! In the order received,: page-9--42.86-USD.pdf; USPS Tracking #: 9214 4903 6271 9022 0002 1800 24, Received: 2025-01-29; page-07--16.13-USD.pdf; USPS Tracking#: 9261 2903 3961 8200 0008 1448 44, Received 2025/02/03; and page-01--20.44-USD.pdf; UPS Tracking #: 1ZJ21 1H4 03 1026 2940, by my doorstep, not addressed to me, Frank Anderson at 651 N Broadway; Green River, UTAH, but which is addressed to: 13598765407; SUN YAOZU; PO BOX 615; Green River UT 84525-0615! The Green River, UTAH 84525 Post Office does NOT deliver to physical addresses!, Received: 2025/02/13.

In the confusion of all of the orders, CapitalOne included: page-07--16.13-USD.pdf; USPS Tracking#: 9261 2903 3961 8200 0008 1448 44, Received 2025/02/03; \$16.13 for One (1) each Mini Oxygen Torch Gas Melting Jewelry Platinum Stainless Steel Goldsmiths' Gadget Metal Soldering Acetylene Butane Burner, which was received in good order! And left out: page-10--26.52-USD.pdf for \$26.52 USD for Two (2) each 225 Amp IGBT TIG/Stick Welders; weight: 90 Lbs. each. And only received two (2) trinket bolts, which are not electrical [225 Amp, AC (alternating current) DC (direct current)], do not have an IGBT (Insulated-gate bipolar transistor), do not have Pulse, a Flex Torch and cable!

AliExpress.com has gone to great lengths to try to keep one from being able to show a picture of what was ordered! In their unreadable proof of the item being sent they do not give a picture of what was originally ordered! This is FRAUD and PayPal is in on the FRAUD! My pdf's can be enlarged so one can clearly see what was ordered and what was received! If one wishes to see higher resolution photos, they are available online on my web site: <http://162.250.19.7/> and show up under the directory "AliExpress-Fraud" as well as in the directory "fraud" My site has been up for over five (5) years and is bullet proof since it is read only! I do not have a domain name and therefore do not use a "Domain Name Server" (DNS) which is the cause of the security problem! My site is continually being searched by all of the web search engines. I post my log files under: /ac0xl/logs/ so one can see how much activity takes place on a web-facing computer from world wide sources.

In the March 2025 survey we received responses from 1,197,680,522 sites across 275,633,322 domains and 13,402,722 web-facing computers. This reflects an increase of 17.0 million sites and 976,381 domains, and a loss of 77,628 web-facing computers.

My ten (10) orders need to be viewed as a whole so one can get a feel of how much FRAUD is taking place on AliExpress.com! I included "AliExpress.com-Terms-of-use.txt" which has some of the rules and regulations that AliExpress professes to use but it seems that they are totally ignored! It appears that they must be using "AI" to match text and not even looking at a picture of the product to see that their "trinkets" do NOT come close to what is advertised! Their "waybills" do NOT match what the ordered products weigh! They ship multiple orders consisting of multiple items under one (1) tracking number! Many of the items I ordered would have needed multiple tracking numbers just for one order! for example: Three (3) PRIMEWELD TIG225X 225 Amp IGBT AC DC Tig/Stick Welder with Pulse CK17 Flex Torch and Cable that weigh ninety (90) lbs. each; a total of twenty-eight (28) Tooliom TL-135S stick inverter DC arc welders with digital display that weigh seven (7) lbs. each; Three (3) Azzuno MIG-165A Aluminum, open spool welders, around twenty (20) lbs. each; one (1) Azzuno MIG 200 Amp, 110/220 volt, multi-process welder around thirty (30) lbs.; One (1) Reboot RBM-1450 MIG Welder, 110V/220V Dual Voltage Flux Core Welder Flux MIG/Lift TIG/Stick 3 in 1 Synergic Large LED Digital Display Welding Machine IGBT Inverter Welder, Item Weight: 13.37 pounds.

All of the sellers have a "GOLD" check mark with a "Choice" rating! even though there are many comments that say, "All I got was a BOLT!"

Out of these six (6) orders, only one had the product that was advertised! All of the other five (5) orders only have trinkets! In this case just more steel selector bolts!

To whom it may concern:

On closer inspection of the "AliExpress.com" web site, as a Systems Analyst, I have to conclude that this web site is designed to facilitate both Supplier and Internal FRAUD! This seems to be similar to the voting machines used in the United States, which are designed to facilitate rigged elections! It also appears that PayPal is also involved with this continuing FRAUD!

Supplier FRAUD: When I had an Amazon order that the Amazon Supplier sent a "trinket" instead of the product, Amazon immediately banned that supplier and refunded my money. There was no "Contact the supplier," but directly contact Amazon! In contrast, AliExpress first wants one to contact the supplier, and that is why AliExpress knows that there are many AliExpress Suppliers who are shipping "trinkets" instead of the advertised product! It only takes a few bad actors to destroy a company, community, or country!

It is not by accident that out of ten (10) orders, I only received three (3) orders as advertised. The first order which took about a month to receive (page 1) was for two (2) 15 pcs MB-15AK MIG Torch Welding Consumables packages: five (5) Gas Nozzles, five (5) Gas Diffusers (nozzle holders) and five (5) 0.8 mm contact tips in one package and five (5) 0.9 mm contact tips in the other package, from: Choice, TW-Tool Store.

The second order I received with actual parts (page 9) was three (3) packages of 30 pcs 15AK torch/gun consumables, ten (10) Nozzles, ten (10) gas diffusers, and ten (10) 0.8 mm contact tips per package from Choice, GUUELD Office Store.

The third order I actually received the item advertised (page 7) was for a Mini Oxygen, Gas Welding Torch for jewelry, from Choice, Shop1103836727 Store.

Orders I only received "trinkets" instead of the actual advertised product for:

(Page 2) Choice, Shop1104489142 Store sent six (6) "trinkets"!

(Page 3) Choice, Shop1104484137 Store sent three (3) "trinkets"!

(Page 4) Choice, Shop1104489142 Store sent five (5) "trinkets"!

(Page 5) Choice, Shop1104484137 Store sent two (2) "trinkets"!

(Page 6) Choice, Shop1104484137 Store sent one (1) "trinket"!

(Page 8) Choice, Shop1104489142 Store sent eighteen (18) "trinkets"!

(Page 10) Choice, Shop1104484137 Store sent two (2) "trinkets"!

Second, scripts are constrained by the same-origin policy: scripts from one website do not have access to information such as usernames, passwords, or cookies sent to another site. Most JavaScript-related security bugs are breaches of either the same origin policy or the sandbox.

Sandbox implementation errors

Web browsers are capable of running JavaScript outside the sandbox, with the privileges necessary to, for example, create or delete files. Such privileges are not intended to be granted to code from the Web.

Incorrectly granting privileges to JavaScript from the Web has played a role in vulnerabilities in both Internet Explorer[102] and Firefox.[103] In Windows XP Service Pack 2, Microsoft demoted JScript's privileges in Internet Explorer.[104]

Microsoft Windows allows JavaScript source files on a computer's hard drive to be launched as general-purpose, non-sandboxed programs (see: Windows Script Host). This makes JavaScript (like VBScript) a theoretically viable vector for a Trojan horse, although JavaScript Trojan horses are uncommon in practice.[105][failed verification]

Since AliExpress is using Alibaba's DeepSeek-R1 an Artificial Intelligence (AI) model trained via large-scale reinforcement learning (RL) without supervised fine-tuning (SFT), which incorporates cold-start data before RL, it is actually learning from watching the FRAUD the suppliers are doing. When I tried to copy my AliExpress Orders page, when I looked at the copy, it was a complete root directory of my computer! This tells me that your JavaScript is running with root privileges and not in a sand box! AliExpress.com is designed to facilitate FRAUD! It only takes a few bad actors to destroy a company, community, or country!

I am posting the directory "AliExpress-Fraud" to my web site: <http://162.250.19.7/> if anyone wants to view the high resolution photos. I manually post my log files to "ac0xl/logs/ on my site so there might be a delay as to when they are posted. My site is secure since I do not have a Domain Name and then have to use a Domain Name Server (DNS). It takes less than four (4) minutes to search the complete IPv4 address list for open port 80 to look for active computers. Most of my traffic is web search bots from all over the world. A Web Server is the new "Printing Press" that publishes to the whole world. I currently have over 53 GB of active data online and my site has been up for over five years.

False delivery dispute rules

1. Definition

"False delivery" refers to the dispute initiated by the buyer when the order status is marked as "Shipped."

Situations that count as false delivery identified by Alibaba.com include:

- 1) The waybill number or related shipping documents uploaded by the supplier during the logistics process were tampered with or forged, or the waybill has expired, or there has been no logistics collection or delivery information for a long period of time.
- 2) The waybill number and related shipping documents uploaded by the supplier during the logistics process do not match the order consignee, delivery address, contact information, weight and volume of the transaction, time information, etc., or the same waybill is reused many times, and the seller has no reasonable explanations.
- 3) Other false delivery situations that can be identified by the platform.

4. Penalties

Refunds for disputes initiated due to false delivery will be reflected in the supplier's dispute rate, and the platform has the right to determine the false delivery claim in accordance with the platform rules, the "Alibaba.com Transaction Violation Penalty Rules", and "Penalty Rules for Providing False Documents", and other relevant rules.

Chapter I Scope of Application and Definition

Article 1 [Scope of application]

These Rules are applicable to all members registered with Alibaba.com (hereinafter collectively referred to as "Members").

Article 2 [Definition]

Penalty for non-compliance refers to a disciplinary measure taken by Alibaba.com against the non-compliance of a Member.

Chapter II Applicable Principles

Article 3 [Equality]

Members are equal in the application of Alibaba.com's penalties for non-compliance.

Article 4 [Repeated non-compliance of the same type]

Members commit repeated non-compliance under the same business type.

Chapter III Purpose of Application

Article 5 These Rules are hereby formulated to better regulate operations on Alibaba.com and its ecosystem, and protect the legitimate rights and interests of buyers and sellers.

Chapter IV Procedures

Article 6 [Source]

The sources of non-compliant information on Alibaba.com include (complaint/report channels):

- (1) Random inspection by Alibaba.com;
- (2) The notification and notice of the administrative authorities;
- (3) The legal instruments of the judicial organs;
- (4) Complaints and reports;
- (5) News media exposure;
- (6) Other channels that comply with applicable laws and regulations.

Article 7 [Determination of non-compliance]

- (1) By any state administrative body or judicial authority;
- (2) By Alibaba.com;
- (3) By a third party other than Alibaba.com on a reasonable basis.

Article 8 [Notice]

Alibaba.com usually notifies Members of penalties for non-compliance by means, including but not limited to Alibaba.com Rules Center, message, and email, except for special scenarios.

Article 9 [Non-compliance appeal and penalty revocation]

- (1) Alibaba.com will remove or partially remove penalties depending on how Members rectify their non-compliance in conduct, products, and information.
- (2) A Member may appeal against an appealable penalty within a specified time limit.

Alibaba.com will approve or reject the appeal upon review of the appeal information. If the appeal is approved, the penalty will be revoked. If the Member fails to appeal within the specified time limit or its appeal is rejected, the penalty will remain effective.

Chapter V Non-Compliance Type and Penalty Measures

Section 2 Types of non-compliance in basic information

Article 13 Compliance in invalid product information

[Definition] It refers to a Member's act of publishing non-compliant product/store information, miscategorizing products, listing the same products repeatedly, providing false prices, SKUs, and/or minimum order quantity (MOQ), or releasing other product-related information that may compromise the platform's reputation.

[Penalty Measures] Disposal of illegal products or information, operation permission control, and account permission control;

Article 19 Provision of document fraud

[Definition] It refers to a Member's act of submitting false certificates on Alibaba.com in violation of any applicable laws or regulations or platform rules.

[Penalty Measures] Operation permission control, and account permission control;

Section 3 Types of non-compliance in transactions

Article 20 Non-compliance in Trade Assurance service

[Definition] It refers to a Member's act of failing to follow the Trade Assurance service rules when using such service on the platform, including but not limited to the following acts: The seller refuses to draft a transaction contract without reasonable reasons; the seller fails to pay for the service in full within the time limit specified in the payment notice; the seller provides false materials, information, or certificates; the buyer gives negative comments or files a complaint maliciously; the seller colludes with the buyer; or the transaction payment fails to arrive at the collection account designated in the transaction contract due to the seller's fault.

[Penalty Measures] Operation permission control, and account permission control;

Article 21 Transaction disputes

[Definition] It refers to any dispute arising between the seller and the buyer during a transaction on the platform, including but not limited to failure to ship the order upon payment, delay in shipment, non-conformity of the order delivered, commitment breach, sale of counterfeit products, malicious collusion, and provision of false certificates.

[Penalty Measures] Operation permission control, and account permission control;

Article 22 Improper trading

[Definition] It refers to a Member's act of deliberately concealing the true transaction information or releasing false transaction information on the platform for the purpose of misleading others or seeking improper gains through the platform.

[Penalty Measures] Operation permission control, and account permission control;

Article 23 Buyers' review

[Definition] It refers to a Member's act of using evaluation tools to publish information not in line with the evaluation principles.

[Penalty Measures] Disposal of illegal products or information, operation permission control, and account permission control;

Section 4 Special market non-compliance

Article 24 RTS market management regulations

[Definition] A Ready to Ship (RTS) item refers to a product with the following three attributes:

- (1) The product can be directly ordered by buyers;
- (2) The lead time of the product at the MOQ is less than or equal to 15 days; and
- (3) The product has at least one workable, country-specific freight template.

[Penalty Measures] Disposal of illegal products or information, operation permission control, and account permission control;

Chapter VI Definition of Penalty Measures

Account permission control:

- (1) Warning: Alibaba.com warns its Members of their misconduct in oral or written form;
- (2) Point penalty: Alibaba.com deducts points over a product or an account;

- (3) Strike penalty: Alibaba.com punishes a Member that seriously infringes upon others' rights based on the "three strikes rule", which means Alibaba.com will close the store of the Member that commits infringement three times;
- (4) Blocking review: Alibaba.com blocks the review content of a Member's store;
- (5) Deleting review: Alibaba.com deletes the rating and review content of a Member's store, without point penalty;
- (6) Freezing funds: Alibaba.com freezes the funds in a Member's accounts (including but not limited to Alipay Global account and Alibaba.com account) until it deems that the risks are under control.

Operation permission control:

- (1) Restricting listing and editing: Alibaba.com prohibits a Member from listing new products;
- (2) Downgrading search results ranking: Alibaba.com downgrades the ranking of part or all of the products of a Member's store in the search results;
- (3) Blocking search results: Alibaba.com blocks a Member's products in the search results;
- (4) Blocking store: Alibaba.com blocks a Member's store;
- (5) Restricting sending of private messages: Alibaba.com prohibits a Member from sending private messages;
- (6) Restricting messaging: Alibaba.com prohibits a Member from sending messages via Trade Manager (TM);
- (7) Prohibiting order placement: Alibaba.com prohibits a Member from drafting and concluding an order through Trade Assurance or OneTouch;
- (8) Prohibiting payment collection: Alibaba.com prohibits a Member from withdrawing its account funds (not limited to US dollars and RMB);
- (9) Restricting quotas: Alibaba.com adjusts and restricts a Member's quotas of Trade Assurance and prepayment collection;
- (10) Freezing funds: Alibaba.com freezes a certain amount of a Member's funds;
- (11) Freezing fund account: Alibaba.com freezes a Member's fund account;
- (12) Restricting participation in marketing activities: Alibaba.com restricts a Member's participation in marketing activities it initiates or co-organizes;
- (13) Disabling Trade Assurance: Alibaba.com grays out the Trade Assurance service sign, so that the sign will not be displayed in the search results and a Member's store page, and the Trade Assurance service is not available;
- (14) Freezing account: Alibaba.com bans a Member from logging into its account and disables the display of its store and products for a certain period of time;
- (15) Closing account: Alibaba.com ceases to provide any service for a Member and does not refund the service fee under certain circumstances.

Disposal of illegal products or information:

- (1) Removing products: Alibaba.com removes the products listed by a Member;
