### Why America is in the State it is in Part XVI

This week I want to start with an overview of what many say is the most important Document in the History of America -The Declaration of Independence. This "Declaration" was written to dissolve the political ties that bound the American people to Great Britain. It was written in 1776 and it wasn't until 1787, another 11 years, that the American patriots won that "Declared" independence on the battle field. In 1789, many of the men that drafted this Declaration of Independence met again in Philadelphia to draft a plan for governing the new nation called "The United States of America" with a document called, "The Constitution for the united States of America" (Yes the small "u" in united is correct). This Constitution would be the "Supreme Law of the Land" but it would NOT violate any of the moral Truths found in the Declaration of Independence. The "Truths of God" are "Self evident" as stated in the Declaration of Independence. These "Self Evident Truths" are based upon a "Higher Law" of right and wrong, Gods Natural Law, from which we derive all human law and to criticize human laws at any time. Look at the "Self Evident Truths" that were written in this document for all to see and know. These "Truths" would be foundational to this new nation. Here is an excerpt from this "Declaration":

"That all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty, and the Pursuit of Happiness -That to secure these Rights, Governments are instituted among Men, deriving their "Just Powers" from the Consent of the Governed".

We are all equal according to our natural Rights that we were born with and we do not get them from the government! Whatever "rights or powers" that government has been given has come from us, from "the Consent of the Governed".

OUR RIGHTS of "LIFE, LIBERTY, and the PERSUIT of HAPPINESS" are God

given and as long as we respect the rights of others we can live our lives as we wish in accordance with Gods Laws that are "written in their hearts". See Romans 2:15 and 2nd Corinthians 3:3.

all that was written in this "Declaration" was based on "Common Law" principals that these men were instituting to "secure" our rights in other words our God-given rights and the power that we give to the government are to never violate those Rights. In fact, the Constitution was written to LIMIT government, not us, and how they must uphold our Rights that were "Granted" by the people as mentioned in the first sentence of Article 1 and of the 10th amendment of the "Bill of rights" it is reiterated again, "the powers... not delegated to the United States by the Constitution are reserved to the People" so the Constitution is for the government officials to follow and not for the "people". The government called "the united States" - a foreign, for-profit investment company which under the leadership of its president, George Washington, was about to start supplying ONLY 19 enumerated services to the American States under an equity contract known as "The Constitution for the united States of America". It was written in 1789 and ratified in 1791 and look who was going to run the "Second Bank of the United States" - the owner of the Bank of England - the Rothschilds and their bankers!

Abraham Lincoln of the United States "a commercial company" became president in 1860 during very tough time in our history. I believe he tried to do some "good things" during his presidency but did some "bad things" that continue even to today. First of all, Abraham Lincoln was a lawyer as many know so kep that in mind. He DID free 4 million slaves which was a great blessing to many. He did make a stand against the "bankers" of his day which may have been the main reason why he was killed.

When the Confederacy seceded from the united States, the Bankers once again saw the opportunity for a rich harvest of debt and offered to fund Lincoln's efforts to bring the South back into the Union by force but at 30% interest! Lincoln responded that "He would never free the black man by enslaving the white man to the Bankers". So using his authority as President, he issued a new Government currency called "Greenbacks" and this was a direct threat to the wealth and power of the Bankers of the United States and England. The London Times responded to Lincoln's decision to issue Greenbacks to finance the Civil war instead of agreeing to the private bankers loans at 30% interest when they wrote; "If this mischievous financial policy, which has it origin in North America, becomes entrenched, then THAT GOVERNMENT (Emphasis

mine) will issue its own money without cost". It would pay off all our debts and we would be without debt. It will have all the money necessary to carry on it's commerce. It will become prosperous to a degree which is without precedent in the history of the world. The brains and the wealth of all countries will migrate to North America, the country must be destroyed or it will destroy every monarchy on the globe". (This is NOT happening today and that is why we have a National debt ONLY owed to the bankers that have enslaved Americans by this fraud!)The Bankers DID NOT WANT LINCOLN TO SUCCEED WITH HIS PLAN!

On April 14th 1865 Abraham Lincoln was assassinated and the "Greenbacks" were pulled from circulation soon thereafter and the American people were forced to go back to an economy based on HEAVY interest from the private Bankers! Here is a few things that Lincoln did that are not good that even effect us today. On March 27th, 1861 11 Congressional Delegates from the southern states walked out leaving Congress adjourned without an agreed upon date to meet again. During that time of absence Lincoln forced a Delaware Corporation (doing business as D.B.A) "The United States of America Inc." and installed the remaining members of Congress as a Board of Directors to continue "conduct business". The Real united States of America never signed any "service contract" with Lincoln's new corporation doing business as "the United States of America Inc." Lincoln merely "traded upon" the Constitution for the united States of America and substituted his corporation as a successor trustee.

In 1862, "the corporate Congress" under Lincoln, changes the meaning of a single word. That word was "person". At the 37th Congress 2nd session, chapter 49 section 68 stated, "A person is no longer a people". It is a "Corporation". From 1862 to today the word "person" means "corporation". On February 2nd, 1871 (6 years after Lincolns assassination) the 41st Congress 3rd session chapter 62, 63, 64 and 65 states "The Congress" (a corporation) declared itself to be the "successor" of ALL United States Corporations and the property of all said "corporations". THAT CLAIM TO OWN ALL CORPORATIONS IS WHY THEY INCORPORATE YOUR NAME WITH ALL CAPITAL LETTERS SHORTLY AFTER YOUR BIRTH!
